1. Maintaining Health and Safety

A. Universal and correct wearing of masks:

- Modifications will be implemented in a timely response to Executive Orders and consultation with the local DOH. (June 1, 2021)
- Students have masks at all times to put on and off as part of instruction or when designated a mask free time where social distancing is maintained.
- Masks breaks during eating or drinking will be permitted and scheduled.
- Masks with valves are not permitted to be used.
- Cloth or paper masks that fit over the nose and around the cheeks and mouth are allowed.

Faculty and staff in classrooms are recommended to always wear a cloth face covering when moving around the classroom to assist a student or group of students. Students will be directed to wear a cloth face covering when interacting directly with faculty or staff members. Classroom routines will be established by each faculty member to manage the wearing of cloth face coverings in the classroom or support area.

B. Physical Distancing

Depending upon the current situation during the emerging situation modifications will be implemented in response to Executive Orders and consultation with the local DOH. The District opened with full enrollment, no virtual platform with the exception of medical considerations following Policy 2412, and 3 foot physical distancing. When social distancing is difficult or impossible, face coverings are required for students and staff unless it will inhibit the individual's health.

All instructional and non-instructional rooms in school and district facilities continue to comply with social distancing standards to the maximum extent practicable.

UPDATE: As per the NJ DOH, the state and county's Covid Activity Level was designated as "Very High." on January 1, 2022. In consultation with the local DOH, the District implemented a short term virtual platform to interested families that commenced January 11, 2022. The temporary platform is being utilized and its use will be evaluated biweekly.

C. Handwashing and respiratory etiquette

Depending upon the current situation during the emerging situation modifications will be implemented in response to Executive Orders and consultation with the local DOH. Hand sanitizing stations with alcohol-based hand sanitizers (at least 60% alcohol) will be set up:

- At entrances and exits of buildings
- In each classroom (for staff and older children who can safely use hand sanitizer)
- Outside lunch rooms and bathrooms

Children ages 5 and younger will be supervised when using hand sanitizer.

Classrooms with sink areas will have stocked stations with soap, water, and alcohol-based hand sanitizers.

Students and staff should wash hands for at least 20 seconds at regular intervals, including before eating, after using the bathroom, and after blowing their nose/coughing/sneezing. Visual reminders will be posted around all sink areas.

D. Cleaning and maintaining healthy facilities, including improving ventilation

In response to the continually evolving situation, the CTSD secured services to conduct an evaluation of all ventilations systems within all facilities. The required work was completed in August of 2020. At that time, a formal schedule of ventilation filter replacement was confirmed. In addition, the full custodial and maintenance department employees received training on the cleaning and maintenance protocols and schedules. The district's measured response is indicated by the changes to the daily schedule for all buildings to allow for seamless maintenance of the facilities. As the maintenance of facilities was confirmed, measured changes, including lunch, were implemented. The maintenance of facilities/equipment included all equipment within each classroom, neutral areas of the buildings, hallways, offices, health offices, bathrooms, outside equipment, and transportation vehicles. PlexiglassD partitions were also secured for individual testing areas and offices.

E. Contact tracing, in combination with isolation and quarantine:

In collaboration with the State, local, territorial, or Tribal health departments, our district physician, and CDC guidelines, contact tracing will be utilized for all required instances of exposure, illness, and related symptoms of COVID-19 according to local CALI scores and other data. Quarantine timeframes will be determined by CALI scores, DOH recommendations, CDC guidance, vaccination status, and local monitoring of data.

F. Diagnostic and screening testing:

A daily wellness screener is in place for the current and coming school year to monitor students and staff and will be utilized as needed. A weekly COVID test, provided by a state approved provider, is implemented for unvaccinated employees.

G. Efforts to provide vaccinations to educators, other staff, and students, if eligible:

Working with the Hunterdon County Department of Health and the Hunterdon Medical Center, the District was able to assist in the coordination and scheduling of vaccinations for the faculty and staff of the district. In addition, the district approved coverage for the employees to maintain a flexible schedule for the vaccinations.

H. Appropriate accommodations for children with disabilities with respect to the health and safety policies:

The CTSD will continue to meet our obligations to students with disabilities. The Extended School Year program will be offered to all eligible students. Specific strategies and considerations for students with disabilities have been and continue to be critical points of discussion for every return-to-school scenario. All special education and related services continue to be delivered in alignment with IEP goals and objectives. Individual student services will be reviewed and continually monitored by Child Study Team members, Special Education staff, and Administration in collaboration with families of students with disabilities to ensure progress oriented and needs based planning.

The district will focus on four primary areas. The first is Social & Emotional support, which will include programs and services for students and staff to address and remediate needs created during the pandemic school year. The academic needs of all students are monitored using a system of benchmark assessments, NJTSS programming, technology integration and 1:1 device program for all students and a summer reading readiness program. Student health services continue to be monitored and addressed by our nursing staff and district physician and in consultation with the local DOH.

All information is posted on the public district website and through various other avenues including monthly Board meetings, Weekly Update articles from the district, and scheduled meetings of our District Advisory Committee in the capacity of providing an overview of information throughout the school year. A draft of the Reopening Plan (Safe Return) was posted on the District web site on June 10, 2021, offered to the District Advisory Committee on June 17, 2021, and it will be presented at the June 28th meeting of the Board for approval. All public comments are archived and offered to the Board. The revision to the CTSD Safe Return Plan was completed on November 17, 2021, approved by the BOE on December 13, 2021 to reflect the inclusion of ARP ESSER III Funds. The plan was posted on the district website on December 23, 2021 for public comment.
